1. On a motion made by Comm. Perez and seconded by Comm. Uribe that we approve minutes of the Regular and Special Commissioners Court Meetings of April 2020. Motion carried with all members voting "Aye" Against "None."

2. On a motion made by Comm. Uribe and seconded by Comm. Trigo that we approve payment of bills. Motion carried with all members voting "Aye" Against "None."

3. On a motion made by Comm. Perez and seconded by Comm. Trigo that we approve Dept. Reports. Motion carried with all members voting "Aye" Against "None."

4. On a motion made by Comm. Trigo and seconded by Comm. Perez that we approve the Continuation of the Local State of Disaster due to Public Health Emergency - COVID-19. Motion carried with all members voting "Aye" Against "None."

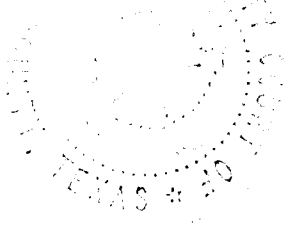
