## NOTICE OF MEETING OF THE COMMISSIONERS COURT

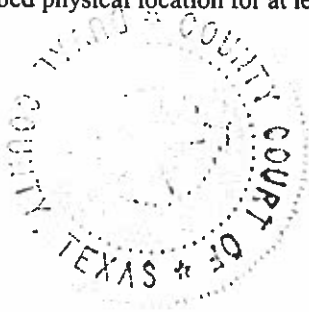

The Commissioners Court meeting will be open to the public; however, in order to prevent the potential exposure to the Coronavirus (COVID-19) anyone who is not vaccinated is encouraged to wear a covering of the nose and mouth, and practice sufficient physical distancing.

1. Roll call, and establish quorum.
2. Pledge of Allegiance.
3. Invocation / Prayer.
4. Call meeting to order. Public recognition / comment / citizen communications.
5. Consideration and possible action to approve any bills, line item transfers, or budget amendments.
6. Discussion and possible action to award bid for the Precinct #2 County Road repair projects as advertised to the bidder whose submitted bid is in the best interest of Duval County and also offers the best value to Duval County and to authorize the County Judge to negotiate the terms of the contract with said winning bidder and approve any matter incident thereto.
7. Discussion and possible action to enter into an Interlocal Agreement between Webb County and Duval County for autopsy services and authorize County Judge to execute final agreement.
8. Consider action to enter into Interlocal agreement between Benavides ISD and Duval County to assist with the construction of drainage and/or other similar issues on BISD property.
9. Discussion regarding the purchase or lease of equipment to maintain county roads.
10. Adjournment.
