**16. On a motion made by Comm. Uribe and seconded by Comm. Garza that we approve the recommendation of the Election Administrator to consolidate**

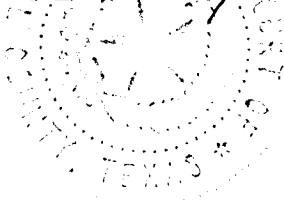
county election precincts for the election to be held November 2, 2021 as follows
