1. On a motion made by Comm. Perez and seconded by Comm. Uribe that we approve the payment of bills. Motion carried with all members voting "Aye" Against "None".
2. On a motion made by Comm. Garza and seconded by Comm. Perez that we approve the budget amendments. Motion carried with all members voting "Aye" Against "None".
3. On a motion made by Comm. Garza and seconded by Comm. Guerra that we approve any line item transfers. Motion carried with all members voting "Aye" Against "None".
4. On a motion made by Comm. Garza and seconded by Comm. Uribe that we adopt Resolution/s to support efforts to secure new voting election equipment utilizing the HAVA grant and approve grant assurances, terms and conditions therein required. 8. On a motion made by Comm. Guerra and seconded by Comm. Garza to adjourn. Motion carried with all members voting "Aye" Against "None".

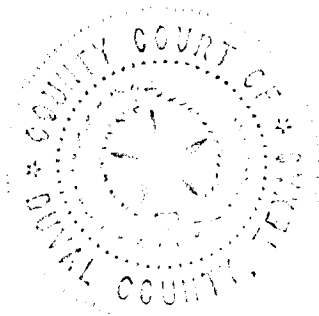
