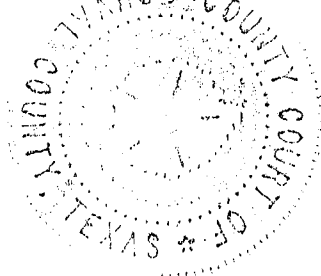

The Commissioners Court meeting will be open to the public; however, in order to prevent the potential exposure to the Coronavirus (COVID-19) everyone will be required to wear a face covering and practice sufficient social distancing. 4. Call meeting to order. Public recognition / comment / citizen communications.
5. Discussion, consideration, and possible action to take further measures to address and respond to the declared COVID-19 public health emergency.
6. Adjournment.

GOV. CODE, Section 551. The Commissioners Court may act in open session on items listed for executive session.
