Duval County will receive sealed bids for a hot mix/asphalt overlay paving project on County Road 409 also known, as (Schuenemann Rd.) Send sealed bids to the attention of County Judge Arnoldo Cantu at the Duval County Courthouse, P.O. Box 189 or 400 E. Gravis Ave., San Diego, Texas 78384 on or before 9:00 a.m. Wednesday, July 9, 2025. Bids received after the due date and time will not be accepted.

The date and time of the bid opening and the phrase "Duval County Pct#4 CR 409 Bid" shall be clearly marked on the outside of the sealed envelope containing the bid. The bids will be publicly opened and read aloud in the Duval County Commissioner's Courtroom at 10:00 a.m. on Thursday, July 10, 2025 at 400 E. Gravis Ave., San Diego, TX 78384.

The successful bidder will be responsible for equipment, logistics, and supply of oil and asphalt/hot mix and will be responsible for all surface prep work prior to commencement of project.

Bids will be to supply Duval County Pct# 4 Key Components for this Project to Include:

Minimum Specifications: Labor, material and equipment necessary to complete asphalt on County Road 409 for approx .6 Tenths of a mile of road, 20' Wide x 2.5 Depth. Please include all warranties and or additional charges that might acquire.

All bids received by the deadline shall be reviewed by Judge Arnoldo Cantu and Commissioner Martin Perez. All bids must include the project standard/specifications and be responsive accurate, and cost reasonable. Duval County will select the vendor who will perform all work required and the contract will be executed between Duval County and the winning Vendor.

You are reminded to bid only on those items designated on the work write up form. In the event the owner should request additional work or deletion of any work from the write-up, or should you feel additional work is required, those items, along with costs, shall be listed on a separate piece of paper or letterhead stationery.

All additional items will be considered separately from the base bid and consideration of any change will be negotiated with the owner after the bid opening.

Bids may be held by the County for a period not to exceed 15 days from the date of the bid opening for the purpose reviewing the bids and investigating the bidders' qualifications prior to the contract award. All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project.

Duval County reserves the right to reject any or all bids and to waive any informalities in the bidding. Winning bid(s) will be awarded during a Commissioner's Court regular or special called meeting after the bids have been evaluated.
