Commissioner Garza Pct. #3- Personnel/Expenses to Other Expenses \$22,327.00

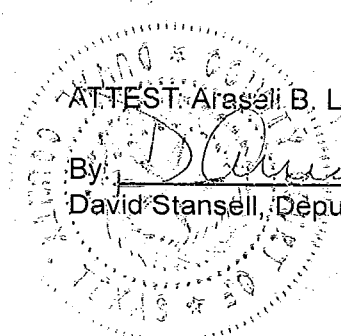
Commissioner Vera Pct. # 2-Personnel/Expenses to Other Expenses \$10,000.00
