**REQUEST FOR RELEASE OF FUNDS**

On or about **May 28th, 2025**, Hardin County, will submit a request to the General Land Office (GLO) for the release of Community Development Block Grant Mitigation (CDBG-MIT) funds appropriated under the Supplemental Appropriations for Disaster Relief Requirements Act, 2018 (Pub. L. 115-123), as amended to undertake a project known as **Hardin County MIT MOD – Street Drainage - Silsbee, #24-065-065-E596 / B-18-DP-48-0002**

for the purpose of **providing an improved drainage system to the residents of Silsbee in all storm events, including both minor storms and major tropical storm events.**

**Description of the Proposed Project** [24 CFR 50.12 & 58.32; 40 CFR 1508.25]:  
Provide Roadside Ditch Improvements. Construction activities will include:

- Culvert Replacements: 2,000 l.f.
- Concrete Headwalls: 2 EA
- Channel Concrete Lining: 3,600 l.f.
- Concrete Roadway Replacement: 2,500 S.Y.
- Roadside Ditch Excavation: 160,000 l.f.
- Seeding/Sodding: 2,500 S.Y.

Project forecast cost \$23,894,500 and will be paid for with \$23,894,500 in HUD CDBG-MIT grant funds administered by the General Land Office.

Project Issues: Endangered Species, Historic Preservation and Wetlands Protection: A full, detailed list of mitigation measures can be found in the Environmental Review Record.

#### Project Size and Beneficiaries

The total area of disturbance will be 25.58 acres and will impact 2,237 persons. Of those persons, 1,333 or (59.59%) are of low to moderate income.

### **FINDING OF NO SIGNIFICANT IMPACT**

Hardin County has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at the **Hardin County Courthouse, 300 West Monroe Street, Kountze, Texas** and may be examined or copied weekdays 9 A.M to 4 P.M.

### **PUBLIC COMMENTS**

Any individual, group, or agency may submit written comments on the ERR to **Hardin County Courthouse, 300 West Monroe Street, Kountze, Texas 77625**. All comments received by **May 27th, 2025** or within eighteen (18) days following this posting (whichever is later) will be considered by Hardin County prior to authorizing submission of a request for release of funds. Comments should specify which part of this Notice they are addressing.

### **ENVIRONMENTAL CERTIFICATION**

Hardin County certifies to GLO that **Wayne McDaniel**, in their capacity as **County Judge** consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. GLO's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows Hardin County to use Program funds.

## **OBJECTIONS TO RELEASE OF FUNDS**

GLO will accept objections to its release of funds and Hardin County's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of Hardin County; (b) Hardin County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by GLO; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Heather Lagrone, Texas General Land Office, PO Box 12873, Austin, TX 78711-2873, [env.reviews@recovery.texas.gov](mailto:env.reviews@recovery.texas.gov). Potential objectors should contact GLO to verify the actual last day of the objection period.
