**ORDER ADOPTING 2019 TAX RATE**

**WHEREAS**, on this the 10<sup>TH</sup> day of September, 2019, came on to be considered for adoption the 2019 tax rate of Hardin County, Texas, by the Hardin County Commissioners Court. The following Members were present:

- Honorable Wayne McDaniel, County Judge
- Honorable L.W. Cooper, Jr., County Commissioner, Precinct 1
- Honorable Chris Kirkendall, County Commissioner, Precinct 2
- Honorable Kenneth Pelt, County Commissioner, Precinct 3
- Honorable Alvin Roberts, County Commissioner, Precinct 4

**WHEREAS**, upon motion made by Commissioner Ken Pelt, Precinct No. 3, and second by Commissioner L.W. Cooper, Jr., Precinct No. 2, it is hereby ORDERED that the Tax Rate for the 2019 Tax Year shall be adopted and set as follows:

- (1) the debt service tax rate is hereby set at \$0.010216 per \$100 valuation
- (2) the maintenance and operation tax rate is hereby set at \$0.569784 per \$100 valuation
- (3) the total tax rate is hereby set at **\$0.5800** per \$100 valuation

This total Tax Rate is less than the rate set for the 2018 Tax Year; and, it is a 6.69% increase over the Effective Tax Rate of 0.543635 per \$100 valuation.




