ORDER ADOPTING 2023 TAX RATE

WHEREAS, on this the 22^{nd} day of August, 2023, came on to be considered for adoption the 2023 tax rate of Hardin County, Texas, by the Hardin County Commissioners Court. The following Members were present:

WHEREAS, upon motion made by Commissioner <u>L.W. Cooper</u>, <u>Jr</u>, Precinct No. <u>1</u>, and second by Commissioner <u>Ernie Koch</u> Precinct No. <u>4</u>, it is hereby ORDERED that the Tax Rate for the 2023 Tax Year shall be adopted and set as follows:

- (1) the debt service tax rate is hereby set at \$0.006573 per \$100 valuation
- (2) the maintenance and operation tax rate is hereby set at \$0.534262 per \$100 valuation
- (3) the total tax rate is hereby set at \$0.540835 per \$100 valuation

This total Tax Rate is the same as the rate set for the 2022 Tax Year; and it is a 12.71% increase over the No-New Revenue Tax Rate of \$0.479865 per \$100 valuation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE MAINTENANCE AND OPERATIONS TAX RATE WILL EFFECTIVELY BE RAISED OVER THE NO-NEW REVENUE MAINTENANCE AND OPERATIONS TAX RATE BY 12.07% AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$1.75.
