

Exhibit "A" Property Description

THENCE South 81°02'40" East, 2,860.26 feet, severing over and across said Koehler Tract, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set in the northwesterly right-of-way of State Highway 326 (SH 326), the easterly line of said Koehler Tract, for the northeasterly corner of the herein described 26.927 acre tract;
